Subject: SU 24 100 Certified Recovery Specialist

PerformCare continues to promote Certified Recovery Specialist (CRS) as an integral part of the continuum of care. CRS should be considered as a service to advance a Member's recovery process. A CRS is an individual with personal, lived experience of their own recovery. By providing insight into the recovery process, they can share a unique perspective with those with similar life experiences. The CRS focuses on addressing barriers to treatment, working with people in their community, teaching and modeling recovery principles, assessing a person's access to recovery supports; including education and vocation, stable housing, and connecting with natural/community supports.

This memo serves as a reminder for all SU & MH IP/PHP Providers to discuss CRS as an after-care service for Members with SUD or Co-occurring Disorders. Aftercare planning with the Member should include the benefits of a CRS to support the Member's ongoing recovery after discharge. The type of CRS support offered in the Member's County (Embedded/Stand alone or standalone only) should be discussed with the Member prior to discharge based on the Member's input and agreement.

CABHC funds CRS for Adults in all five CABHC counties (Cumberland, Dauphin, Lancaster, Lebanon, Perry residents), with one (1) standalone CRS provider, and nine (9) Licensed SUD OP clinics that also provide CRS services embedded in the SUD OP clinic.

Direct referrals can be made to the standalone provider for CRS. However, in the embedded CRS model, Members must receive SU OP services at the clinic to receive CRS services through that SU OP clinic. A direct referral for CRS cannot be made for providers using the embedded CRS model. SU OP must be the recommended level of care and the Member can choose a provider that offers embedded CRS. The SU OP provider will connect the Member to the CRS within their organization. A list of CABHC CRS Providers by County and type CRS services available, is attached for reference.

PerformCare funds CRS for Adults as standalone service in four (4) provider locations serving both TMCA counties (Franklin and Fulton) A list of TMCA CRS Providers is attached for reference.
