- **Purpose:** To provide clarification about the use of intelligence quotient and adaptive functioning tests as tools for diagnosing Intellectual Disabilities.

- **Procedure:** 1. Providers, on behalf of a Member, should submit requests for standardized IQ and Adaptive Functioning tests as part of a psychological evaluation on the appropriate PerformCare form.
 - 2. This request is forwarded to a Physician/Psychologist Advisor (PA).
 - 3. The PA reviews the reason for the request and the tests being requested. Such testing shall be administered and interpreted only by a licensed psychologist or by a psychologist in preparation for licensure under the direct supervision of a licensed psychologist.

The Family and/or requestor will be referred to their school district for this type of testing.
