Subject: MH 25 103 Psychiatric Rehabilitation Referrals

PerformCare believes that Psychiatric Rehabilitation is an integral part of the continuum of care and should be considered as a service to advance Member's recovery process. Psychiatric Rehabilitation Services (PRS) are collaborative, person-directed, individualized and are evidence-based in their approach. PRS focus on helping individuals develop skills and access resources needed to increase their capacity to be successful and satisfied in the living, working, learning, and social domains of their choice. PRS promotes recovery, full community integration and improved quality of life for persons who have been diagnosed with a mental illness that seriously impairs functioning.

PerformCare funds PRS for Adults in all five CABHC counties, including the recently opened program in Dauphin County. This memo serves as a reminder for all Providers to discuss Psychiatric Rehabilitation as part of treatment planning when consider all services that could support a person's recovery and especially for after care services from Mental Health Inpatient and Mental Health Partial Programs. TCMs and all other Providers are strongly encouraged to coordinate with the Member and make referrals for PRS.

PerformCare Clinical Care Managers will include PRS as part of discharge planning discussions for Mental Health Inpatient and Partial Hospital Programs with the expectation that both Levels of Care explain the benefits of PRS with Members prior to discharge and make referrals when a member expresses an interest. A List of PRS Providers by County is attached for reference.
