Policy: To provide FBMH and TCM providers with a mechanism to request to continue TCM during FBMH Services.

Purpose: To determine the use of FBMH Services concurrently TCM.

Definitions: **TCM:** Targeted case management including Intensive Case Management (ICM), Resource Coordination (RC) and Blended Case Management (BCM) where available.

Acronyms: **CCM:** Clinical Care Manager
FBMHS: Family Based Mental Health Services
IP: Identified Person

Procedure:

1. FBMHS regulations require that FBMHS teams provide case management and crisis intervention functions 24 hour a day, 7 days-a-week.
2. Because of this requirement, TCM services would be warranted to only families with complex behavioral health needs.
3. If FBMHS is approved and the Member has TCM, the FBMHS team will be the lead for both treatment and case management and there should be no duplication of services. In order to ensure this occurs, the TCM and FBMHS team will need to coordinate closely.
4. The FBMHS treatment plan and the TCM services plan will indicate how the providers will work together and reflect the

- goals of each service during FBMHS delivery. The goals of each service must be identified and may not be duplicative.
5. All routinely required documentation must be submitted to the PerformCare CCM for requesting initial and reauthorization for TCM services. The TCM provider will be responsible for the submission.
