Subject:	AD 21 102 Reminder to Collect Social Determinants of Health (SDoH) Data to Address Members' Unmet Needs		

Summary: PerformCare issued Provider Notice AD 19 102 Collecting Social Determinants of Health (SDoH) Data to Address Members' Unmet Needs July 1, 2019 indicating that PerformCare will assess, identify, and address health care and social determinants of health needs in the populations we serve; helping to enable them to live healthier lives and achieve maximum independence.

Background: Addressing SDoH is increasingly a priority as evidenced by OMHSAS requirements to address SDoH in Value Based Purchasing arrangements, Community Based Care Management Programs, and our Performance Improvement Project (PIP) called Successful Prevention, Early Detection, Treatment and Recovery (SPEDTAR) for Substance Use Disorders: Addressing the Continuum of Care for Individuals with Substance Use Disorders.

Unfortunately, during the PIP baseline measurement year, PerformCare Substance Use providers submitted Z-code diagnoses on only 9.5% of Substance Use provider claims, which significantly underrepresents the population of Members who could have been assessed for and diagnosed with an applicable Z- Code during the measurement period of time.

Action Needed: Effective immediately all Mental Health and Substance Use Providers must begin to include the appropriate supplemental ICD-10 diagnosis codes on claims submitted to PerformCare to report SDoH factors. Providers are also encouraged to develop processes to periodically reassess Members for changes in SDoH and make appropriate updates to Z Code diagnosis information in your internal systems to reflect when SDoH factors have changed or been addressed and no longer affecting the Member, such as the Member secured stable housing. The inclusion or lack of Z codes will not impact the adjudication of claims or the processing of encounters. Note: SDoH should not be used as the admitting or principal diagnosis.
