PerformCare has designated a list of zip codes that are considered rural and paid at a differential rate for IBHS since these areas identified have historically been difficult to staff and serve Members. A list of qualifying zip codes is included with this notice as Attachment 1. If an IBHS provider is serving a member from one of these zip codes identified, the TN modifier should be added to the code. A full list of applicable codes is included as Attachment 2.

The address of record provided by DHS to PerformCare and verified by the Provider will be used to determine Member zip codes and eligibility for the rural rate. If the address on file is not where the member is residing, the address will need to be updated with the County Assistance Office. PerformCare will not be able to pay a claim billed with the TN modifier if the member's zip code is not on the list. The TN modifier cannot be used when providing IBHS services via telehealth. The TN modifier is to help offset increased costs for travel.
