This Provider Notice serves to clarify billable activities for Intensive Behavioral Health Services (IBHS) in response to provider questions generally centered on whether non face to face activities are billable under IBHS Individual, IBHS Group, and ABA billing codes.

Providers have also raised similar questions to OMHSAS. OMHSAS reissued their IBHS FAQ dated 2/9/2021, which includes the below question and answer.

5. Why can providers of behavior consultation-ABA services bill for indirect activities, including data analysis, but providers of behavior consultation services cannot bill for these activities?

The national ABA codes include codes that allow for billing of activities, such as data analysis, which was taken into account in the development of the ABA rates. While providers of behavior consultation services cannot bill directly for activities such as data collection, documentation, and staff oversight, the time associated with these activities was taken into account when the fee schedule rate for behavior consultation services was developed.

As indicated in Provider Notice IBHS 21 100 ABA CPT Billing Guide, PerformCare has adopted the 2019 CPT supplemental guidance for ABA codes. Please note that TMCA, CABHC and PerformCare used the same assumptions as OMHSAS in setting our IBHS fee schedule rates. Both TMCA and CABHC adjusted IBHS rates compared to BHRS rates to incorporate additional requirements under IBHS regulations and billable activity assumptions consistent with the OMHSAS FFS rates published in OMHSAS Bulletin 20-01 and OMHSAS-21-03. Please note that telephone services are not billable for IBHS except for telehealth during the COVID 19 Public Health Emergency.
